A. PRODUCT INSPECTION

The State Department of Health or any authorized representative of the local Department of Health or of Armada Area Schools shall have the right to inspect the premises, facilities and methods on any pizza or product delivered to determine whether or not the contract is being properly performed.

B. PRODUCT SPECIFICATION

All products must be produced under State of Michigan code provisions. <u>A</u>

formulation statement that certifies that the product meets the Grain and

Meat/Meat Alternate requirements for school meals must be provided.

Samples are to be provided when requested by the authorized school official.

Bids are to be submitted on the following product specification (for each serving):

- 1. 14" Round Pepperoni and Cheese (or equivalent if square)
- 2. Cut <u>evenly</u> into 8 slices in order to provide required meal components to meet USDA guidelines.
- 3. Crust must be a minimum of 51% Whole grain

C. DELIVERY SPECIFICATIONS

Ability to deliver to all buildings on the specified serving day 20-30 minutes prior to each lunch time. Exact daily per lunch quantities to be determined. We anticipate a volume of 3,200 pizzas for the 2023-2024 school year.

- 5. The pizza **MUST** be evenly cut in order to provide required meal components to meet USDA guidelines.
- 6. Deliveries MUST be on time.
- 7. Two shirts for every regular staff member to be provided. The shirt will be worn on pizza service days.
- 8. The Food & Nutrition Department will not be responsible for pizza ordered by other departments outside of the food service department. These departments will be billed separately.
- 9. The proposed agreement or contract may be renewed for an additional one-year period provided both parties agree no later than July 1, 2024 to an extension. The extension will be at the same price and under the same terms and conditions as they exist in the current contract except that no further renewal shall be made.
- 10. Armada Area Schools are exempt from all applicable federal and state taxes. The federal tax-exempt number and the Michigan tax-exempt form may be obtained from the school district prior to commencing business. All bids are to be made taking this fact into consideration.
